### ***1. What Information Is Collected?***

Your personal information is collected from HRT's website.

HRT collects the personal information that you provide to us. This includes information you register on HRT's website, purchased product information, a product of service, giveaways, contests, promotions, links, competitions, and any sister sites that are affiliated with the HRT Network.

### ***2. Information collected includes***

Payment Data-Payment Data Transfer (PDT) is a notification service that, once activated, can send transaction-related information immediately to merchants who are using PayPal payment buttons (PayPal Payments

Standard). Merchants can display these transaction details on their website to confirm the buyer's payment was successful. Merchants can also use this information to automatically fulfill orders for digital goods. This feature applies to PayPal Payments Standard transactions, including Buy Now, Donation, Subscriptions, and Shopping Cart button.

### ***3. Your rights over your information***

We believe you should be able to access and control your personal information no matter where you live. Depending on how you use Paypal, you may have the right to request access to, correct, amend, delete, port to another service provider, restrict, or object to certain uses of your personal information (for example, direct marketing). We will not charge you more or provide you with a different level of service if you exercise any of these rights.

If you buy something from a PayPal-powered store and wish to exercise these rights over information about your purchase, you need to directly contact the merchant you interacted with. ## ***7.Privacy Policy***

Our Privacy Policy was last updated and posted on January 1, 2021. ### **a.Our privacy policy outline**

Before or at the time of collecting personal information, we will identify the purposes for which information is being collected. We will collect and use personal information solely to fulfill those purposes specified by us and for other compatible purposes, unless we obtain the consent of the individual concerned or as required by law.

### **b.Retaining Personal Information**

We will only retain personal information as long as necessary for the fulfillment of those purposes. We will collect personal information by lawful and fair means and, where appropriate, with the knowledge or consent of the individual concerned. Personal data should be relevant to the purposes for which it is to be used, and, to the extent necessary for those purposes, should be accurate, complete, and up-to-date.

### **c. Your protection**

## ***8. Definitions***

"Non-Personal Information" is information that is not personally identifiable to you and that we automatically collect when you access our Website with a web browser. It may also include publicly available information that is shared between you and others.

### ***11.Our Website uses "Cookies"***

to identify the areas of our Website that you have visited. A cookie is a small piece of data stored on your computer or mobile device by your web browser. We use cookies to personalize the Content that you see on our Website. Most web browsers can be set to disable the use of Cookies. However, if you disable Cookies, you may not be able to access functionality on our Website correctly or at all. We never place Personally Identifiable Information in Cookies. Geographical Information When you use the mobile application, we may use GPS technology (or other similar technology) to determine your current location to determine the city you are located in and display information with relevant data or advertisements.

## ***12. What are cookies?***

A cookie is a small amount of information that's downloaded to your computer or device when you visit certain websites. We use several different cookies on the website, including strictly necessary, performance, advertising, and social media or content cookies. Cookies make your browsing experience better by allowing the website to remember your actions and preferences (such as login and region selection). This means you don't have to re-enter this information each time you return to the site or browse from one page to another. Cookies also provide information on how people use the website, for instance, whether it's their first time visiting or if they are frequent visitors. Read more about cookies (and other similar tracking technologies) and how we use the data collected through these technologies.

## ***13. What cookies do we use and why?***

Some cookies are necessary to allow you to browse our website, use its features, and access secure areas. The use of these cookies is essential for the website to work. For example, we use user-input cookies for the duration of a session to keep track of a user's input when filling in forms that span several pages.

We also use functional cookies to remember choices you've made or information you've provided, such as your username, language, or the region you are in. This allows us to tailor your website experience specifically to your preferences. For example, authentication cookies are functional cookies that are used for the duration of a session (or persistent, if you agree to the "remember me" function) to allow users to authenticate themselves on subsequent visits or to gain access to authorized content across pages. The functional cookies we use include:

- User-centric security cookies detect authentication abuses for a limited persistent duration, like repeated failed login attempts. These cookies are set for the specific task of increasing the security of the service.
- Multimedia content player session cookies (flash cookies) are used for the duration of a session to store technical data needed to playback

video or audio content (e.g. image quality, network link speed, and buffering parameters).

- Load-balancing session cookies are used for the duration of the session to identify the same server in the pool for the load balancer to redirect user requests appropriately.
- User interface customization persistent cookies are used to store a user's preference regarding a service across web pages.

HRT Network is dedicated to user experience and we use many tools to help us improve our website and our commerce platform. To this end, we use reporting and analytics cookies to collect information about how you use our website or our merchants' storefronts, and how often. These cookies only gather information for statistical purposes and only use pseudonymous cookie identifiers that do not directly identify you. The performance cookies we use include:

- First-party analytics cookies - We use these cookies to estimate the number of unique visitors, to improve our websites and our merchants' websites, and to detect the most searched for words in search engines that lead to a webpage. These cookies are not used to target you with online marketing. We use these cookies to learn how our websites and our merchants' websites are performing and make relevant improvements to improve your browsing experience.
- Third-party analytics cookies - We also use Google Analytics and other third-party analytics providers listed below to help measure how users interact with our website content. These cookies "remember" what our users have done on previous pages and how they've interacted with the website. For more information on Google Analytics, visit [Google's information page](#). For instructions on how to opt-out of Google Analytics, see below.

Advertising cookies are used on our website to tailor marketing to you and your interests and provide you with more personalized service in the future. We automatically receive information from your web browser or mobile device. This information includes the name of the website from which you entered our Website, if any, as well as the name of the website to which you're headed when you leave our website. This information also includes the IP address of your computer/proxy server that you use to access the Internet, your Internet Website provider name, web browser type, type of mobile device, and computer operating system.
